### **INSURANCE REPORT:**

- The 2012 insurance dues will remain the same as last year.
- 2500 participants were registered for insurance.
- Small number of claims occurred during the year.
- Dues are due by April 1, 2013.

### **DONATION:**

- \$3,300.00 donation was made to the Civil War Trust for preservation of 964 acres of land at Kelley's Ford.
- \$6700.00 will be used later in the year for preservation efforts at a place to be decided later.

### **SCHOLARSHIP OPPORTUNITY**

- Each Battalion will receive \$500.00 to go towards a scholarship fund.
- The Division will decide on its parameters and provide that information to the Battalions at a later date.
- If the money is not used in one year, the monies may carry over to the following year.

### **SAFETY ISSUE**

- Muskets being made by Middlesex Village Trading Company and Loyalist Arms that are light, without a pressure test stamp, and appear low cost are very dangerous.
- Battalions should not allow these weapons on the field for safety reasons. The guns are not being tested and the barrels are not made to withstand the gun powder. Mainly, these weapons are being made to be hung on the wall.
- Suggestion was to provide an example to Sgt. Majors at a future Division Meeting.

### **CIVILIANS**

- Civilians have been very involved in the events this year and involved with the soldiers. Members greatly appreciate the civilians and the efforts they have made to the hobby.

### **PROBATION**
